

**TOWNSHIP OF PEQUANNOCK**

**ORDINANCE NO. 2018-11**

**ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE TOWNSHIP OF PEQUANNOCK, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY AND APPROPRIATING THE SUM OF \$868,000 FOR FINANCING THEREOF**

**BE IT ORDAINED** by the Township Council of the Township of Pequannock, County of Morris, as follows:

**SECTION 1.** \$190,000.00 is hereby appropriated from the General Capital Fund Balance; \$186,000.00 is hereby appropriated from the General Capital Reserve for Vehicle Replacement; \$155,000.00 is hereby appropriated from the General Capital Reserve for DPW Equipment; \$310,000.00 is hereby appropriated from the General Capital Reserve for Road Resurfacing; \$27,000.00 is hereby appropriated from the General Capital Reserve for Data & Office Equipment, thereby in aggregate appropriating \$868,000 for the following improvements in and by the Township of Pequannock, in the County of Morris, New Jersey:

<b>Purpose</b>	<b>Amount Appropriated</b>
(a) Replace Approximately 15 PC Systems that are 4 years old or older for various municipal offices; purchase of a replacement High Volume Digital Network Copier.	\$ 27,000
(b) Repairs and renovations to municipal buildings including Town Hall, the Henning House Fire Safety Annex and Security Camera's for the DPW Annex.	\$ 21,000
(c) Purchase of Replacement Shotguns for the Police Department.	\$ 13,500
(d) Acquisition and installation of equipment and fixtures for the Fire Department including replacement of SCBA Cylinders; acquisition of 5" Hose; acquisition and installation of Parking Lot Bollards and an Electronic Message Board.	\$ 62,500
(e) Purchase trees to replace ones that have died in the public right-of-way	\$ 10,500
(f) Improvements to Pequannock Valley (PV) Park including improvements to the Basketball Court and purchase of Large Beach Umbrella's	\$ 11,000
(g) Resurfacing of various roads in the Township to include milling and paving and various curb and drainage repairs as necessary. Drainage improvements at various locations as needed though out the Township.	\$ 321,500
(h) Purchase of DPW and Parks equipment including a Concrete Planer, Combination MIG Welder and Salt Brine Manufacturing System.	\$ 35,000

(j) Purchase of new and replacement vehicles including 1) replacement of an administrative inspector's vehicle for use by the Construction Office; 2) acquisition of an SUV for the Police Department; 3) Replacement of DPW Dump Truck 613; 4) Purchase of a Utility Body Truck for DPW to support increased brining operations and 4) Replacement of DPW Pick-up Truck 68.	\$ 366,000
TOTAL	\$ 868,000

**SECTION 2.** The improvements hereby authorized and the purposes for which this appropriation is made includes all costs and materials necessary therefor and incidental thereto. An amount not exceeding \$9,300 for items of expense listed in and permitted under NJSA 40A:2-20 is included in the costs indicated herein for the improvement.


**SECTION 3.** The Capital Budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies herewith.
