### ORDINANCE NO. 2014-20

#### ORDINANCE AMENDING CHAPTER 129 OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF PEQUANNOCK AND REVISING THE FIELD USAGE FEES

**BE IT ORDAINED** by the Township Council of the Township of Pequannock, in the County of Morris and State of New Jersey, as follows:

**Section 1.** Chapter 129, Section 129.05 entitled "Group Use Policy/Township Parks", Subsection 129.05.050 which shall be re-titled "Field Use Scheduling and Fees" shall be amended to read in its entirety as follows:

129.050050 "Field Use Scheduling and Fees"

A. Field use scheduling policy. Field use scheduling for outside groups shall be in the discretion of the Director of Parks and Recreation who shall have the authority to establish such policies as the Director deems necessary to administer field usage. Each organization seeking to use a Township field shall designate one individual as the responsible party for field scheduling and reservations. That individual shall submit a list of coaches within the organization. A certificate of insurance shall be required prior to reserving a field. The Director shall have the authority to suspend an organization which fails to comply with field usage policies.

B. Field Usage Fees.

1. The fee for non-profit organizations based in Pequannock Township shall be \$10.00 per hour for practices and \$20.00 per hour for games. The organization must submit a Pequannock Township address and proof of its not for profit status.
2. The fee for all other organizations shall be \$50.00 per hour for practice and game.
3. There shall be no fee for Recreation and Township sponsored organizations, including, but not limited to, Little League.

**Section 2.** Chapter 79, Section 79.05 entitled "Fees for Use of Township Designated Playing Fields and Picnic Areas" is hereby repealed.

**Section 3.** If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this

Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**Section 4.** All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

**Section 5.** This Ordinance shall take effect immediately after final passage and publication in the manner provided by law.
