The only exemption is for non-potentially hazardous baked goods (i.e. cookies, brownie, cakes). If you offer these items, you MUST post a sign next to the items stating the following: THESE ITEMS WERE PREPARED IN A PRIVATE HOME THAT IS NOT SUBJECT TO LICENSING AND INSPECTION BY THE LOCAL HEALTH AUTHORITY.

#32 6.2(o) Exterior Walls/Roofs, Barriers: Observed the chicken wire worn with holes and not attached to the soffit of the structure. Must replace chicken wire to protect and minimize against the entry other.

#35 4.2(c)2 Provided and accessible: Thin-probed temperature measuring devices provided for monitoring thin foods (ie.) Meat patties and fish fillets.
