Meetings/Trainings: Sue and Gail participated in a Zika Virus webinar presented by NJDOH.

- Gail and Christie attended a North Jersey Health Collaborative meeting where the top five priority areas were identified for Morris County in order of priority: Obesity; Cardiovascular Disease; Diabetes; Access to Behavioral Health; and Heroine. Accreditation Update:

Gail created and deployed a demographics survey for staff per the request of Rutgers so that the class could be customized. Results of this survey were forwarded to Rutgers.
