Animal Control

Riverbend Feral Cats: An on-site meeting was done with Christianne Smith ACO, Gina McConeghy, REHS and the property managers at Riverbend. We walked the entire complex to assess what maintenance issues had to be addressed to prevent the feral cats from entering the sub surfaces of the buildings. Lattice structures were to be installed to prevent the cats from going under the decks of the properties. The flood screens were also to be repaired, remounted or replaced if missing. All garbage cans were to be replaced to keep out wildlife, namely raccoons and feral cats. The head of maintenance was to be the responsible person to set the cat traps and call if cats were found in a cage. He would be responsible for bringing the captured cats to Pequannock when Christianne could not be in town. His information was forwarded to FP Police Department as a person assisting in the capture of the cats. Numerous traps were to be purchased by Riverbend, along with a camera system to address residents as well as trespassers who might be feeding the cats.
